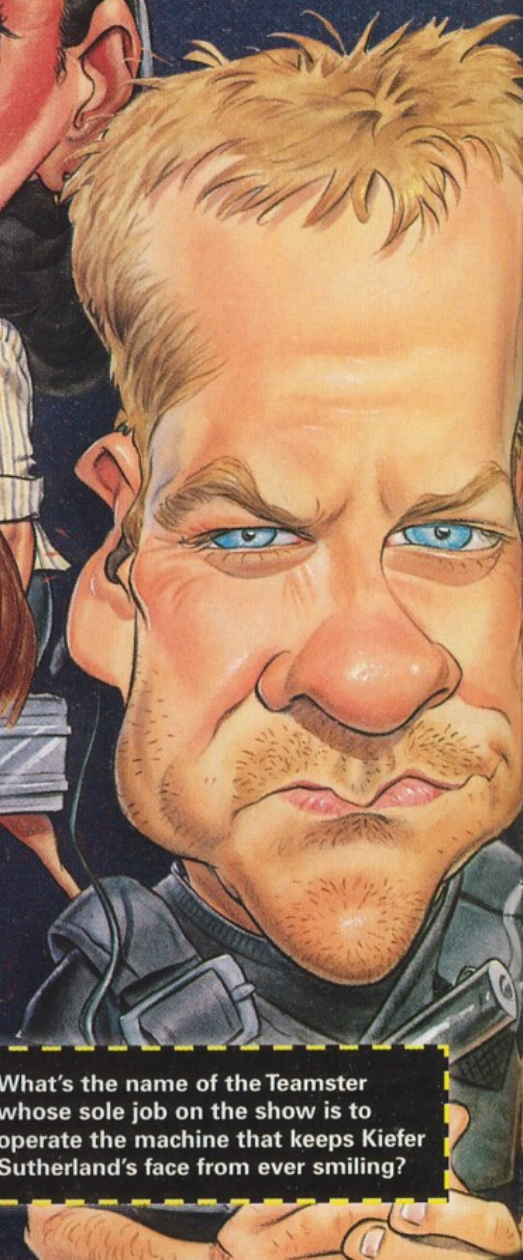
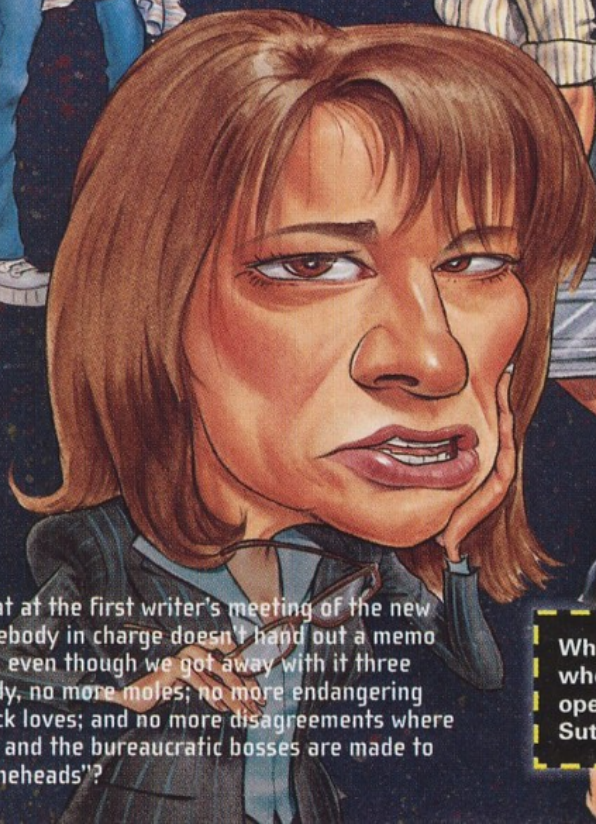
When you watch *24* without the commercials, it's a lot shorter — so for DVD collections, did you ever think of changing the show's title to *18*?
